Covid-19 Update

Call the Director

We are frequently 'sanitising' during COVID and there seems to be more occasions of revokes occurring. Perhaps 'sticky cards' can contribute to this.

Revokes are dealt with in Laws 61 to 64, which are quite detailed, so it is always a good idea to call the director. I would like to discus a couple of issues.

Establishment of a Revoke

A revoke becomes established when the revoking SIDE plays to the next trick.

Up until this happens, the revoking side may declare the revoke, and correct their play.

The revoker is not obliged to admit the revoke. However, it will often be simpler to fix the mistake immediately. There may not be the need for any penalty.

If Declarer has revoked, this is simply fixed by withdrawing the card, and replacing it with the correct suit. No penalty card for declarer, or Dummy. If either Defender calls the revoke before it is established, then the revoking card simply becomes a Major penalty card, which may not cause too much of a problem. It will need to be played immediately if the offender is on lead, otherwise, if partner is leading, there may be lead directions.

Dealing with an established revoke.

If the revoke has been established, then this trick will be transferred to the other side <u>if won</u> by the revoker.

A second trick will also be transferred from the **side** that has revoked. [Maximum penalty: 2 tricks].

If the offender has not won any trick after the revoke, but partner has, then in this case the trick is taken from the partner.

When the above trick transfer is insufficient.

On occasions, not often thankfully, the Director will need to assess if the revoke has caused more damage. Please explain carefully if you feel that the revoke has caused more damage than the above trick adjustment. A recent example had Declarer drawing trumps, on the second draw of trumps a defender failed to play. This 4/1 deal of trumps complicated the play of trumps as the fourth trump was the Jack. Declarer, with a second suit, was concerned with losing control. This was definitely something for the Director to sort out, and an adjusted score was awarded.
